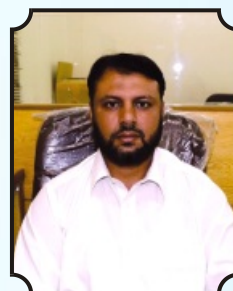

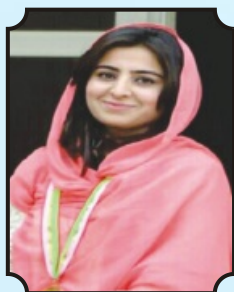

Introduction to the institute

Pakistan Institute of Community Ophthalmology (PICO) was established in 1998, on the recommendations of the WHO as a joint project through partnership between Government of Khyber Pakhtunkhwa and International Centre for Eye Health (ICEH) London (UK). The institute is also financially and technically supported by Sightsavers International (UK), CBM (Germany), Light for the World (LFW) (Austria), Fred Hollows Foundation (Australia) and Brien Holden Vision Institute (Australia). Later on in 2010 it was declared by Government of KP as an autonomous Institute and now it is working under the Board of Governors' Medical Teaching Institute (MTI)/HMC.



Our Vision:

“Improving Quality of Life by eliminating avoidable blindness”.

Mission:

“Work towards an enabling environment which contributes towards strengthening eye health care system”.

Aims & Objectives:

The aim of the Institute is to reduce the prevalence of blindness and visual impairment and to improve the quality of life of people with blindness, visual impairment and other eye ailments through the following:

1. Human resource development for comprehensive eye care with an aim to improve the quality and coverage of eye care services for the people of Pakistan and other developing countries.
2. Conduct clinical, epidemiological and social research on the burden of blindness & visual impairment, its social and economic consequences, identifying risk factors and barriers faced by people in availing eye care services in order to improve eye care service delivery to people in under privileged areas.
3. Extend comprehensive eye care services to district and sub-district levels so that eye care services become available, accessible, acceptable and affordable to all segments of population.
4. Plan capacity building of eye care teams at national, provincial, district and sub-district levels in the management of eye care programs so that eye care services become effective and efficient.
5. Arrange advocacy campaigns to get resources & support for above activities.

Administrative Structure

Pakistan Institute of Community Ophthalmology (PICO) is an autonomous institute working under the Medical Teaching Institutions (MTI) Act of 2015. It is situated in Hayatabad Medical Complex and is headed by the Director who works under the Board of Governors (BoG) of MTI/HMC. The Director is helped by Deputy Directors, senior faculty members, an academic council and other non-faculty members of the institute.

Role of the Director

1. The Director is the overall in-charge of all academic, administrative and financial activities.
2. Represents the institute at Board of Governors of Hayatabad Medical Complex and other relevant forums.
3. Deals with all matters of academic interest in the institution at all time.

Computer Labs & Access to High Speed Internet

Well-Equipped Demonstration Rooms & Class Rooms with Video Conferencing Facility

PICO provides facilities to students of exposure to the latest available relevant technology at its modern demonstration rooms & class rooms with state of the art video conferencing facility for online lectures.

Raja Mumtaz Regional Learning Resource Centre

Students are required to prepare assignments, research articles, dissertation and thesis. For these activities the Institute has established Raja Mumtaz Regional Learning Resource Centre (RLRC), one of the best learning resource centers in the country. RLRC provides up-to-date information to students through more than 5000 printed books, 15 national and international journals subscription, dictionaries, encyclopedias, census reports, Newsletters and other course related books. Audio Visual section includes CD ROM's, slide sets, DVDs with player & CDs. RLRC has a facility of 04 computers with internet access. Printing, scanning and photocopying facilities are also available for students and research scholars of the institute. The reading area of the RLRC has a capacity for 50 students at a time.

Optical Laboratory

The Institute has a state of the art optical lab to facilitate students in learning modern techniques of dispensing spectacles.

Clinical Department for Practical Training

The institute also has the privilege to access the full-fledged Department of Ophthalmology at Hayatabad Medical Complex (HMC) for practical training. Department of Ophthalmology at HMC is one of the 05 centers of excellence for eye care in the country. Students get hands on training under the supervision of experienced ophthalmologists and optometrists with the cooperation of the whole eye care team.

Opportunity to Participate in Community-Based Surveys, Eye-Camps & Workshops

The Institute provides opportunities to students for participating in community based blindness surveys, eye camps and workshops to enhance their skills.

Introduction to Bachelor of Sciences in Optometry (BS Optom)

Bachelor of Sciences in Optometry is a Four year professional optometry course which includes clinical and practical phases of optometry as well as the theoretical and fundamental aspects of vision sciences. It is spread over eight semesters of professional courses, including a research project.

According to the world council of optometry "Optometry is a healthcare profession that is autonomous, educated, and regulated (licensed/registered), and optometrists are the primary healthcare practitioners of the eye and visual system who provide comprehensive eye and vision care, which includes refraction and dispensing, detection/diagnosis and management of diseases in the eye, and rehabilitation of condition of the visual system".

Objectives:

At the end of the course the students will be able to:

- Perform vision test and analyze results.
- Provide quality refractive services to the community through their advanced training in specialized area of Optometry to meet the needs of secondary and tertiary eye care institutions.
- Increase the coverage of Comprehensive Eye Care and ensure quality and equitable delivery of these services.
- Provide pre and post-operative care to patients undergoing eye surgeries.
- Perform Orthoptics / Low Vision / Contact Lens assessment & provide treatment such as vision therapy or low vision rehabilitation.
- Assist ophthalmologist in outpatients and theater.
- Perform some minor surgical procedures (removal of super facial foreign bodies, irrigation of lachrymal passages).
- Diagnose some disease of the eye like cataract, glaucoma, diabetic retinopathy, age related macular degeneration and refer appropriately.
- Perform and run all the diagnostic test / equipment need for ophthalmic diagnosis.
- Conduct appropriate basic, applied and clinical research.

Eligibility Criteria:

All the candidates applying for admission in Bachelor of Sciences & Optometry course must fulfill the following requirements.

1. **Qualifications:** The candidates applying for admission against any category of seats must possess FSc. Certificate (Pre-Medical) with at least 50% unadjusted marks (2nd division) from any Board of Intermediate and Secondary Education in Pakistan.

OR

Must possess any certificate from Foreign University / Board other than Afghanistan which, in scope and standard is found equivalent to the FSc. (Pre-Medical) examination of Pakistan, subject to the following:

- i. The examination is recognized as equivalent to FSc. (Pre-medical) by the inter Board Committee of Chairman (IBCC), Islamabad. Introduction to Doctor of Optometry

Course

Doctor of Optometry is a five-year professional optometry course which includes clinical and practical phases of optometry as well as the theoretical and fundamental aspects of vision sciences. It is spread over ten semesters of professional courses, including a research project.

According to the world council of optometry "Optometry is a healthcare profession that is autonomous, educated, and regulated (licensed/registered), and optometrists are the primary healthcare practitioners of the eye and visual system who provide comprehensive eye and vision care, which includes refraction and dispensing, detection/diagnosis and management of diseases in the eye, and rehabilitation of condition of the visual system".

Objectives:

At the end of the course the students will be able to:

- Perform vision test and analyze results.
- Provide quality refractive services to the community through their advanced training in specialized area of Optometry to meet the needs of secondary and tertiary eye care institutions.
- Increase the coverage of Comprehensive Eye Care and ensure quality and equitable delivery of

these services.

- Provide pre and post-operative care to patients undergoing eye surgeries.
- Perform Orthoptics/ Low Vision / Contact Lens assessment & provide treatment such as vision therapy or low vision rehabilitation.
- Assist ophthalmologist in outpatients and theater.
- Perform some minor surgical procedures (removal of superficial foreign bodies, irrigation of lachrymal passages).
- Diagnose some disease of the eye like cataract, glaucoma, diabetic retinopathy, age related macular degeneration and refer appropriately.
- Perform and run all the diagnostic test / equipment need for ophthalmic diagnosis.
- Conduct appropriate basic, applied and clinical research.

Introduction to the Master in Public Health (Community Eye Health)

Scope of MPH (CEH) program

Current Status of Public Health Education in Pakistan and other developing countries.

- Global vision 2020 identifies human resource development as one of its priorities in public eye health.
- National program for eye health in Pakistan indicated the need for public health specialists (community eye health), to manage various eye care programs at national, provincial and district level (integrated into primary health care).
- This MPH (CEH) program endeavors to fulfill the needs and demands of Pakistan and other countries in educating and training of human resource in Public Health.

Aims and Objectives

The MPH (CEH) degree is designed to prepare students to address the broad mission of public health, defined as "enhancing health in human populations through organized community efforts, utilizing education, research, and community service".

- To introduce the candidates to the magnitude, causes and distribution of burden of various

diseases including blindness & visual impairment in the world, region, country, province and district.

- To introduce them to the study of the health system in district / Province / Country and identify the issues in the optimum functioning of the health system.
- To enable them to plan, implement, analyze and interpret different epidemiological studies for need assessment of burden of diseases with their causes including blindness, visual impairment and other eye ailments.
- To introduce them to the concept of different level of health care including primary health care, primary eye care and the integration of Primary Eye Care into Primary Health Care.
- To enable them to plan, implement, monitor and evaluate health / eye care activities at primary, secondary and tertiary levels.
- To enable them to help clinicians in relevant epidemiological research.
- To enable them to understand the foundation of health promotion practice and their philosophical and value base.
- To enable them to develop educational material relevant to health promotion and prevention of disease.



- To introduce them to the concepts of rehabilitation in individuals who are suffering from disability including irreversible blindness, at all levels.
- To enhance their managerial skills in order to improve the health care ensuring patient safety.

Curriculum outline for MPH (CEH)

The course will be spread over two years with 60 Credit hours of study.

Year one: will constitute taught courses in the forms of various teaching modules of 48 credit hours.

Year Two: will constitute an assignment and dissertation written under supervision at their own workplace equal to 12 credit hours each.

Academic Policy



Academic Policy

- A course file for each program is maintained in the Institute . Before the beginning of the classes, each teacher will submit a course plan, including topics to be taught each week, the number of assignments and quizzes, and the distribution of marks. Complete record of the course will be maintained and submitted by the teacher on monthly basis, including attendance topics covered, home assignments etc. The course director will review course files periodically to ensure that course plans have been followed faithfully.
- The Institute will retain the original documents of the students for the whole duration of the course. These will be returned to the student either on completion of the course or in case the student wishes to leave the Institute in the middle of the course.
- Applications and photocopies of the academics documents will not be returned to the unsuccessful candidates.
- A student must have attended at least 75% attendance in a course in order to be allowed to sit in the Final Examination.
- Each course is assigned a Lecturer or Assistant Professor for grading assignments and quizzes, taking tutorial classes for weak students, and in general, helping the teacher in conducting the course.
- Candidates from all over Pakistan / other countries are welcome to apply.
- Govt. employees must apply through proper channel.

Rules Regarding Payment of Fees / Fine for Students

1. All fee and dues of the first semester must be paid within 10 days of grant of admission, otherwise his/her admission will be cancelled and seat will be offered to the next candidate on merit list. For subsequent semesters fee and dues if not paid within 15 days of start of semester a fine of Rs. 50 per day will be imposed. If the student fails to pay his/her fee and dues within 60 days, his/her name will be struck off from the institution.
2. In case, the student want to continue his / her studies he / she will apply for re-admission in the same semester. Subject to approval of Admission Committee, he / she have to deposit full admission fee for that semester.
3. Fines once levied will not be condoned.

1. Percentage of fee shall be applicable on all components of fee, except for security and admission fee, which will be fully forfeited.
2. Time line shall be calculated continuously, covering both weekdays and weekend.

All late admission cases (Admission offered after commencement of classes). The days for fee refund shall be counted the date of admission as per above table.

Examination Rules

- a. In each semester, students are required to appear in quizzes, mid-terms, final Examination, give presentation, participate in group discussion, and submit projects / assignments / laboratory reports, where ever applicable. These will have different weightage contributing towards the overall assessment in percent marks and be determined by the teacher / instructor concerned, according to Regulation 8 of the KMU semester system regulations.
- b. In case a student joins a course after it has started, he / she shall be responsible for any missed quizzes, assignments and lectures. The marks in missed quizzes etc. shall be considered zero while make-up tests, assignments, projects and labs can be arranged in consultation with the institution.
- c. There are no Supplementary / Special Examination in the Semester System; if a student fails in a course; he / she is required to repeat the whole semester.
- d. In case a student repeats the course which has already been taken, the old grade will be substituted with the new grade, (for CGPA calculation) and both the grades will reflect on his / her transcript, i.e. old course grade and new course grade.
- e. Students shall be responsible to meet the requirements and deadline published for each semester in the academic calendar of the university. Students will also be expected to know and adhere to the rules, regulations, course loads, prerequisites, and policies of the university, as well as those of the institute in which they are enrolled.
- f. Minimum attendance in a course required to be eligible for final exams is 75%.
- g. If a student fails to attend any lecture during the first four weeks after the commencement of the
- h. Semester as per announced schedule, his/her admission shall stand cancelled automatically without any notification.
- i. Research Project / Thesis if applicable for any program is of six credit hours and its Weightage is included in Final Semester.
- j. Student has to submit the final copy of his / her thesis duly approved by his / her supervisor to the Examinations Section of the University, within 40 days after the last paper of Final Term Examination.



Terminology Used:

A. "Academic Calendar" means a written academic activities schedule as provided under Regulation 4(2) of the KMU Semester system regulations.

b. Conduct of Semesters: There shall be two regular semesters in an academic year. Each semester will be spread over 18 weeks with inclusion examinations i.e.;

- I. Spring Semester: February June
- II. Fall Semester: September January

c. "Credit Hour (C.H)" means one hour lecture per week per semester.

d. "Cumulative Grade Point Average (C.G.P.A)" means cumulative grade point average as provided under Regulation 10(4) of the KMU Semester system regulations.

e. "Grade Point Average (G.P.A)" means a grade point average as provided under Regulation 10(3) of the KMU Semester system regulations.

f. "Summer Session" means a special semester offered by the institute as the case may be, to meet the credit hours deficiencies or courses deficiencies during summer vacations.

Institutional Rules

1. Students are required to attend at least 75 percent of the lectures/seminars/tutorial and clinical classes each year, failing which his/her name, shall not be forwarded to the controller of examination, of the University for Purpose of appearing in the concerned examination. It applies also to students who are readmitted after failing in Annual and Supplementary examinations.

2. The margin of twenty-five percent of absence in theoretical / lecture, practical classes and demonstrations and in hospital practice is intended to cover absence only on account of sickness or special emergency considered justifiable by the Director. A written application should be sent to the Director by the student or his / her parent or guardian, reporting his / her illness or cause absence along with medical certificate in case of illness. Students will be marked absent / ineligible for university exams if his / her overall attendance is below 75 % even in the presence of a medical certificate.

3. Students of third & fourth year are required to continue clinical practice in the hospital during vacations according to the schedule given to them by the Institute.

4. All the trainees who are required to attend OPD / Eye Ward / OT since 8:00 am have to get their attendance marked at PICO before leaving for the clinical work. If any student is found absent from the clinical department during working hours, he/she will be marked absent for the entire day. A warning will be issued or an explanation will be called from students if found absent continuously for three days.

5. No students are allowed to leave the lecture room, practical class or a hospital ward without the permission of his/her teacher or until the teaching session ends.

6. Students are expected to respect the individual rights of others during their stay in the institute. Specifically, strict action will be taken if any student is found involved in harassment and discrimination against any other student.



1. Students must carry their own instruments with them during their practical placements & are not allowed to use Hospital equipment without permission. Students will be fined for Rs. 100 if found without his / her instruments required for clinical practice during training on the clinical side.
2. Students are not allowed to play any unauthorized game in the premises of the institute / hospital at any point of time.
3. Outsiders are not allowed in the institute at any point of time without prior permission of the administration.
4. Students are liable to pay for any damage to institutional / hospital property intentionally or unintentionally. In case, of intention damage students may be punished by the Director accordingly in addition to the replacement of the damage.
5. Students are required to take prior appointment if they wish to meet the faculty members / In-charge Course / Deputy Director / Director in person.
6. It is desirable for students to engage themselves to reasonable extracurricular activities such as sports and literary during leisure time only.
7. Students are not allowed to address any press conference or write to the press on the political or related subject or matters concerned directly with the administration of the institute, university or any government or educational institution in Pakistan or abroad during their stay at the institute.
8. Students are not allowed to display posters or banners of any kind without approval of the Director during their stay at the institute.
9. Students are not allowed to setup societies / groups on any basis and or hold meetings within the premises of the institute / hostel during their stay at the institute.
10. Any complaints from the students shall be dealt with accordingly by the concern course in-charge. It will be his / her decision to consult disciplinary committee and or inform higher authorities depending on the seriousness of the issue. Final decision will be taken by the Director of the institute.
11. The decision of the extreme penalties such as permanent expulsion / rustication from the institute will be taken by the academic council.
12. Students will be struck off from the institute roll automatically if they are found absent for 04 weeks without any application.
13. A Student will be marked absent in absence of application / medical certificate. Rupees 50 will be charged from the student as fine for each absentee he / she makes.
14. Scholarships of students selected on open merit will be canceled if found absent from the course for two continuous weeks.
15. Students are not permitted to stay in the lecture rooms after prescribed hours of lectures.
16. Students are not allowed to carry any kind of weapons in the institute / hospital.
17. Students are not allowed to use / possess narcotics during their stay at institute. Any student found in possession of or using narcotics or fire arms will be expelled from the institute / hostel immediately. In case of any complaints / suspicion hostel rooms and students belonging can be searched without prior notice.
18. Parents / Guardians are expected to co-operate with the authorities of the institute in maintaining discipline in the institute.



The Tutorial System

The object of the tutorial group system is to promote mutual well-being and understanding between the students and the faculty of the institute. Each tutorial is to look personally in to all the difficulties of students (individually) and to report to the Director of the institute for opinion and advice, if required. For this purpose:

- i. The Students are divided into groups, each group being made up of an equal proportion of students from each year.
- ii. The faculty members are assigned the duties of tutors.
- iii. Students once placed in a group in their 1 year will remain in the group until he/she leave the institute. Under no circumstances transfer of a student from one group to another will be permitted.

i. The group will meet twice in each semester or on the demand of the students as occasion arises.

1. A class representative is selected by the students at the beginning of the each academic year. The role of the Class Representative is to take care of student's academic problems and communicate it to the relevant course in-charge.

2. All accidents, including minor ones have to be reported to the teacher faculty member concerned.

3. Absentees would be sent to the Course In-charge who may impose fine and take appropriate action.

4. Late comers by 10 minutes of the class initiation may be marked absent.

5. The Institute administration holds the right to expel a student at any time if not satisfied with his/her conduct or character during the course.

Uniform Policy

The institute follows strict uniform policy and students are required to wear white coats over their uniforms while attending Lectures, examination halls and the hospital.

Female Students Uniform: Gray Shirt, White Shalwar, White Dupatta, Black Shoes, neat and clean specified white long overall up to knee length and Navy Blue sweater/ blazer.

Male Students Uniform: White Shirt, gray trouser, black shoes, neat and clean specified white long overall up to knee length and Navy Blue sweater.

TIMING

The Institute timings are from 8:00 AM to 3:00 PM on all working week days (Monday-Friday)

VISITORS

Visitors are not allowed during working hours i.e. classes/practical/wards etc. However parents/guardian can meet concerned staff on prior appointment.



Admission Policy

Admission Policy

1. All the courses are advertised through 02 National newspapers (English & Urdu). Simultaneously the courses are also advertised on PICO website.
2. All the applicants are required to submit completed applications on the prescribed forms within 15 days of the advertisement.
3. Application forms along with prospectus are made available on PICO website (www.pico.org.pk) from the day of advertisement.
4. Incomplete applications are not considered for admission.
5. Students are required to appear in KMU-CAT test, if they are applying for the course of BS Optom/ Doctor of Optometry (OD).
6. Students are required to appear in Entry Test for the courses of MPH (CEH), MPH (General) and M. Phil Vision Sciences.
7. Short listed candidates have to appear in an interview for aptitude testing.
8. Special interviews / tests / physical examinations are arranged for students applying on special seats i.e. Hafiz e Quran & disabled.
9. Possession of valid domicile certificate:
 - i) The candidate must possess a valid domicile certificate of concerned area.
 - ii) The domicile certificate once submitted with the entrance test form cannot be changed and shall be considered as final.

Seats for Disabled Candidates for All Courses

The disabled candidates selected by the "Disability Committee" with a valid domicile of Khyber Pakhtunkhwa/FATA fulfilling all the other criteria for admission to PICO can apply on these seats. To be considered on open merit as well as disabled candidates seat, the candidates must apply against both the categories. However, it will be the choice of the candidate to avail open merit or disabled seat. The disabled candidates are required to provide a registration certificate from the Social Welfare Department Government of KP, Stating that;

- He/ She is a disabled candidate, but
- He/she is mentally fit and physically able to carry out his/her studies and can perform professional duties after qualifying.

The disabled candidate will be required to produce a certificate from a Govt. certified specialist as per attached Proforma in the prospectus as per specimen. Such certificate will only make him/her eligible to apply against the reserved seats for disabled.

A Medical Board constituted by Director PICO will make final decision about the suitability of the candidate for admission against the reserved seats.

Eligibility Criteria for Disability for All Courses

a. Disability for the purpose of admission to Medical and Dental Colleges in KP is defined as that degree of physical impairment which puts the candidate at disadvantage as compared to a normal person for acquiring education before entering PICO, but otherwise is capable of performing his/her duties satisfactorily as student and later on as a Professional. The terms "severely disabled and comparison of disabilities" are not



- i. A severely disabled person is ineligible.
 - ii. Disease/ disabilities affecting different organ systems are in no way comparable.
- b. The disability shall be of permanent nature.
 - c. The candidate shall be declared disabled by the Medical Board for disabled candidates.
 - d. The Medical Board will issue a certificate of disability.
 - e. In case of any dispute regarding the decision of Medical Board, an appeal should be made within 48 hours before the Appellate Medical Board. The decision of the Appellate Medical Board shall be final.
 - f. Selection against these seats will be done by PICO Admission Committee on merit from amongst the certified disabled candidates.

Medical Board to Examine the Disabled Candidates

1. Medical Specialist
2. Surgical Specialist
3. ENT Specialist
4. Eye Specialist
5. Orthopedic Specialist
6. Psychiatrist
7. The Chairman Admission Committee may co-opt any specialist relevant to the disability as member, on need basis:

a) Appellate Medical Board for Disabled Candidates: In case of any dispute regarding disability, an appeal should be made within 48 hours to the Appellate Medical Board. The Appellate Board will comprise of the serving/ retired Professors of all the concerned specialties and will be constituted by the Chairman PICO admission committee. The decision of the Appellate Medical Board shall be final, after approval of Chairman PICO admission committee.

8. Students applying on Ex-FATA (Merged Areas) or other backward areas / AJK, Gilgit Baltistan will have to produce location certificate from their respective Deputy Commissioners / Political Agents.

a) Criteria of Eligibility for Ex-FATA (Merged Areas) Reserved Seats:

These seats are reserved for the Ex-FATA areas of the Province of Khyber Pakhtunkhwa. The Ex-FATA (Merged Areas) are identified as Khyber District, Kurram District, Mohmand District, North Waziristan District, South Waziristan District; Malakand District included protected areas (Swat Ranizai and sam-ranizai) & Bajaur, Tribal area attached to Peshawar, Kohat and Hazara Division & Shirani Area.

To be considered on open merit as well as quota seats, the candidates must apply against both categories through separate admission forms. However, it will be the choice of the candidate to avail open merit or Ex-FATA (Merged Areas) area seat.

The candidate must fulfill the following criteria;

- 1) Possess valid Ex-FATA (Merged Areas) domicile certificate.
- 2) His/her father must possess a valid domicile of Ex-FATA (Merged Areas). In case father of the candidate is not alive then the mother's valid domicile of Ex-FATA (Merged Areas) will be considered.
- 3) Fulfill all other criteria laid down for admission in Pakistan Institute of Community Ophthalmology (PICO).

b) Criteria of Eligibility for Backward Areas of Khyber Pakhtunkhwa:

These seats are reserved for the backward areas of the Province of Khyber Pakhtunkhwa. The backward areas are identified as Upper & Lower Dir, Chitral, Kohistan, Gadoon Area in Swabi District, Haripur District i.e. Kalanjar Field Kanungo Circle of Tehsil Haripur and Amazai Field Kanungo Circle of Tehsil Ghazi, Merged Area of Hazara&Mardan Division and upper Tanawal, Swat District, Buner District, Torghar District & Shangla District.

To be considered on open merit as well as quota seats, the candidates must apply against both categories through separate admission forms. However, it will be the choice of the candidate to avail open merit or backward area seat.

The candidate and his/her father must be having a valid domicile certificate of the backward area against which he/she is submitting the application and if father is not alive then the mother's valid domicile of the backward area will be considered.

- 1) The candidates must have obtained education from class-I till Matric (complete Sessions) Including SSC with Science from institutes within the concerned backward areas of Khyber Pakhtunkhwa and have passed examinations from the same institutes provided such facilities exist in the area.
- 2) Where there are no high schools or colleges available or the facility for teaching science subjects does not exist, candidate must have obtained their primary and middle education from the respective backward area and obtained their SSC(science) within the district of domicile.
- 3) In case of non-existence of school non-availability of the facility for teaching science subjects, the candidates have to provide a solid proof in the form of a certificate (as per specimen annexed) duly verified by the concerned EDO education and countersigned by the concerned DC of the concerned district.
- 4) In case of non-availability of candidates fulfilling the above mentioned criteria, the selection will be made on merit from amongst the candidates on the basis of domicile of the concerned backward area.

a) Seats for AJK, Gilgit Baltistan & Baluchistan (For OD/BVS/OTC Course Only): One seat each is reserved for candidates of Azad Jammu & Kashmir, Gilgit and Baltistan and Baluchistan. The candidates have to produce a valid domicile certificate. Admission is purely on merit amongst the candidates from Gilgit Baltistan & Baluchistan. Rest for the criteria remains the same. Admission process is considered completed on the last date of admission announced by the institute:

- 1) The selected candidate has submitted an acceptance letter. The selected candidate has submitted the standard affidavit.
- 2) All the students have to submit their dues according to the fee structure and schedules given in the prospectus.
- 3) The selected candidates are strongly advised to visit our website (<http://www.pico.org.pk>) regularly.

2. Overseas students must apply on the prescribed procedures are as under:

i. Seats for Overseas Students: These Seats are for applicants who hold a valid Foreign Nationality. One of the parents of the applicant should also hold a valid Foreign Nationality. The applicant should fulfill admission criteria laid down by Higher Education Commission, Government of Pakistan, Islamabad, and the admission criteria of PICO.

ii. The student has to bring the original documents for the admission for verification at the time of interview. Limited number of scholarships is available on merit basis.



i. International Students: International students should apply through their respective embassies and should keep in mind the fact that the processing of their application may take longer than the expected time.

Procedure for Admission of Overseas Students

1. Qualification: Equivalent Education qualification as for National students recognized by HEC.

2. A complete set of official transcripts of academic record in institute, graduate school, and/or professional schools, with certification of degrees conferred, courses taken and grades received.

3. A statement of objectives, summarizing past education, training and experience, as well as interests and future aims is required. A curriculum vitae and list of publications, if any, should be included with the application form.

4. All overseas students have to follow the regulations of Inter Board Committee of Chairmen (IBCC)

<http://www.ibcc.edu.pk/> of Pakistan in seeking admission at Pakistan Institute of Community Ophthalmology and have to follow the following steps:

✓ Overseas student seeking admission in Pakistani University/Degree Awarding Institution has to apply for admission direct to the concerned university/institution and get the letter of confirmation of admission.

✓ University will send a copy of admission letter to IBCC and HSC

✓ IBCC to confirm and endorse admission to Ministry of Interior

5. Student must approach the Pakistani mission abroad for the visa and submits the following documents:

✓ Application Form (Student Visa Form)

✓ Photocopy of passport

✓ Photograph

✓ Educational Documents

✓ Admission letter of university / institute

6. The Pakistani High Commission in the respective countries forward all the documents to Ministry of Foreign Affairs Islamabad for further processing.

7. Ministry of Foreign Affairs forwards all documents to Ministry of Interior for security clearance

✓ Copy to Ministry of Education/Health

✓ Copy to IBCC

Admission Cancellation Policy:

In case a student want to cancel/ leave the course before completion will pay next two semester fee as a penalty to the institute.

Admission of the candidates will be cancelled if

- i. It is found at any stage of course that the candidate was not entitled for admission according to the PICO admission policy.
- ii. Candidate is found medically unfit at any stage of course.
- iii. Candidate fails to report for admission and fail to deposit the fee within due period.
- iv. Any document, information provided by a candidate is found false / fake or fabricated at any stage of course.
- v. It is found that candidate was not entitled for admission in preference to the other candidates who applied for admission at any stage for any course.
- vi. All the selected candidates are to get their admission done on the schedule date. If a candidate fails to do so, he / she shall be taken as “not interested” and his / her seat shall be automatically offered to the next candidate on merit list.

Attested Documents Required with Application Form

Applicants must attach attested photocopies of the following certificates and documents with the application forms. The documents and certificates must be attested by Gazetted Government servant. The stamp of the officer must bear his/her full name, designation and current place of duty.

3. A copy of Hafiz-e-Quran certificate if the candidate claims to be Hafiz-e-Quran.
4. A copy of Computerized National Identity Card of the applicant OR A copy of Form B.
5. A copy of Computerized National Identity Card of the father of the applicant if the father is not alive, a copy of the National Identity Card of the mother or guardian.
6. Migration certificates (After confirmation of admission).
7. Domicile certificate / Passport Nationality
8. Final degree MBBS/ BDS / BS Optom / OTC / equivalent certificate along with transcripts. HEC verified Testimonials.
9. Academic certificate of MBBS / BDS / BS Optom/ equivalent transcript. If any incase of MPH (CEH) / MPH (General) / M. Phil Vision Sciences.
10. 04 passport size colored photographs with white background of the applicant attested on the back.
11. NOC for in-service Candidates.

Important Note:

1. Photocopy of admission form is not acceptable.
2. All applicants must appropriately fill and sign the admission form and undertaking.
3. Incomplete/not properly filled form in any respects shall be rejected. Avoid rewriting / cutting, while filling the form.



4. Applications should reach office of the PICO on or before the closing date and time.
5. Applications received after the due date and time will not be entertained for admission.
6. Applicant must study the Admission Policy and the prospectus in order to understand rules and Regulations regarding admission procedure, distribution of seats, examination/tuition fees etc.
7. The domicile, DMC of FSc. (Pre-Medical/Equivalent Examination, SSC and other certificates once submitted with the entry test form cannot be changed and shall be considered as final.
8. Revision of result or improvement of marks by the board/IBCC after the finalization of merit list shall not affect the merit list of admission of current year in any way. All the above mentioned certificates issued after the dates fixed for receipt of application forms shall not be entertained.
9. Application forms with any false statement by the candidate will be rejected.
10. If any certificate submitted by the candidate is found false, or forged during his/her admission shall be cancelled forthwith and he/she shall be blacklisted for admission to any professional colleges in Khyber Pakhtunkhwa. Further legal action can be taken against the student under the existing criminal laws.
11. Undertaking on judicial stamp paper or Rs. 50/- duly attested by notary public/Political Agent as per specimen given in the prospectus/admission form (After confirmation of admission).

Hostel Facility:

The students of PICO come from both abroad and across Pakistan, hostel facility / accommodation is provided only for female students in a rented hostel near the institute. Priority will be given to those students whose residency is far away from the campus or living in other districts of Pakistan.

Students seeking admission in a hostel should apply on the prescribed form (along with one attested passport size photographs), which can be obtained from the Office of Student Affair Section PICO. Only those students who are on the regular rolls of PICO and are enrolled for a diploma, degree programme as full-time students will be allowed for admission in the hostels.

PICO will provide Security, Cook and caretaker facility only while students will pay their utilities.
